*Exit 48, Round Swamp Road. At light make left. Take Round Swamp Road to the end (2.6 miles). Make left at light onto NY 25 - Jericho Turnpike. Proceed west for 1 mile-The Crest Hollow Country Club is on the right*

*From Long Island Expressway: (heading west)*

*Exit 48, Round Swamp Road. At light make right. Take Round Swamp Road to the end (2.6 miles). Make left at light onto NY 25 - Jericho Turnpike. Proceed west for 1 mile-The Crest Hollow Country Club is on the right.*

*From Northern State Parkway: (heading west)*

*Exit 39, Round Swamp Road. Make right & proceed on Round Swamp to the end (1.3 miles). Make left at light onto NY 25 - Jericho Turnpike. Proceed west for 1 mile-The Crest Hollow Country Club is on the right.*

*From Northern State Parkway: (heading east)*

*Exit 39, Round Swamp Road. Make left & proceed on Round Swamp to the end (1.3 miles). Make left at light onto NY 25 - Jericho Turnpike. Proceed west for 1 mile-The Crest Hollow Country Club is on the right.*
